## ABSTRACT

The National Archives and Records Administration (NARA) and the Assassination Records Review Board (ARRB) identified the need for an assessment of questions regarding the photographic evidence of the John F. Kennedy assassination, including motion picture films, stills and X-Rays.

This Report addresses the vintage of selected motion picture films held by NARA and the camera and printer hardware used to capture the original and derive copies.
